account information is up to date and accurate.

CHECKLIST



Correct Address

Confirm your address is up to date with County Federal. If we were a source of earned income or you have a home loan with us, you'll have a 1099 or 1098. Login to online banking to double check your information.



Correct Phone Number

Haven't gotten around to adding your new mobile number? Now is the time to make sure your phone number is correct and you don't miss out on any important communications.



Direct Deposit Information

Review your information (account and routing numbers) to confirm your funds will be added to the correct account.



Check Categories & Notes

If you've used the Category & Note feature in Online Banking, we recommend downloading and reviewing your account notes for any discrepancies over the year.











Tax Preparation Help

Let County Federal help prepare your taxes. We have once again partnered with the Internal Revenue Services (IRS) and United Way Bay Area's "Earn It! Keep It! Save It!" Volunteer Income Tax Assistance (VITA) program to help provide free tax preparation to households earning less than \$56,000 a year. Appointments
